- **Unauthorized Repairs:** All maintenance must be performed exclusively by Bmore Strings. Repairs attempted by the renter, teachers, or unauthorized third parties void coverage and may incur restoration fees.

4. Sizing Exchanges & Upgrades

- Renter may exchange the instrument for a different size (e.g., 1/2 size to 3/4 size) at any time during the rental period at no extra exchange charge.
- The monthly rental rate will update to the standard rate for the new instrument size/tier if applicable.

5. Rental Equity & Purchase Credit

- **Equity Accrual:** 100% of the base monthly rental fee paid for up to one year (excluding tax and protection plan fees) accrues as store credit toward the purchase of a new, full-sized, non-discounted instrument of equal or greater value.
- **Non-Transferable:** Equity credit is non-transferable and holds no cash value. Equity is forfeited if the account falls into default or if the instrument is returned without immediate purchase.

6. Returns, Termination & Default

- **Return Procedure:** To terminate this agreement, the instrument outfit must be returned in good working condition to Bmore Strings. Rental charges continue until the outfit is received by the Bmore Strings.
- **Default:** If payment is overdue by 30 days or more, Bmore Strings reserves the right to declare the full retail value of the instrument (\$_____) immediately due.
